Motion made by Councilor Ballard to reconvene in executive session under A1 to discuss personnel matters. Second by Councilor Johnson at 8:07 pm. Return to regular session at 8:35 pm. Councilor McConnell made motion to move to terminate the employment and contract of Town Manager, and direct legal counsel to prepare required severance and separation agreement. Second by Councilor Johnson. Mayor Purvis called for a vote on this. All in favor, none opposed.




